Dublin Airport (EIDW) Installation of Advanced Visual Docking Guidance System and Aircraft Fixed Electrical Ground Power - Phase 1, Including Reconfiguration of Aircraft Parking Stands Located West of Pier 1.

Commencing late February 2023, for a period of 26 weeks approximately works will be in progress on phase 1 of the above project.

During construction to optimise stand availability, existing stands will be withdrawn from service permanently on a phased basis and the introduction of new stands will also be on a phased basis as the project progresses. The sequential withdrawal of stands will be promulgated locally.

Details of the existing stands and proposed stand amendments are shown overleaf and on the Appendix to this supplement. Exact dates and times of construction works, including taxiway restrictions will be promulgeted by NOTAM with reference to this supplement.




